Pursuant to Decree No.63/2014/ND-CP dated June 26, 2014 detailing the implementation of several provision of Law on Bidding regarding the selection of contractors;

Persuant to the Decision No.415/QĐ-NDQN dated 12, April 2021 issued by Board of Management of Quang Ninh TPJSC regarding bid result of the bidding package No.6 (EPC package): Engineering, Procurement and Supply Goods, construction and Installation of DeNOx Plant.

The Owner, Quang Ninh Thermal Power Joint Stock Company, would like to announce: Cancel the EPC bid package No. 6 "Engineering, Procurement and Supply Goods, construction and Installation of DeNOx Plant" under the bidding contractor selection plan of "Upgrading, retrofitting flue gas treament systems of Quang Ninh Thermal Power Plant" project, with the reason "All bidding proposals do not meet the requirements of bidding documents, request for proposals " under Clause 1, Article 17 of the Law one Bidding No. 43/2013 /QH13 dated November 26, 2013 and the clause item 39.1.a Chapter Instruction to Bidders of Bidding Documents. Details are as follows:

- The following Consortiums did not extend Bid validity and Bid security according to the Section 17.2, Chapter I-Instructions to Bidders of the Bidding Documents. Therefore, your Bidding proposals were not to be considered for further evaluation, including:
- The SEC AMECC Consortium (Shanghai Electrical Group Co.,Ltd Shanghai Electrical (Vietnam) Co.,Ltd AMECC Mechanical Construction JSC);

 - The 2nd stage technical proposal did not meet the requirements of the scope of work and some other technical contents of the 2nd Stage Bidding Documents (the Contractor declared that the installation of SCR do affects the operation of the ID fan and Air heater but you stated that remedial work not to be within the scope of the Contractor, SCR installation and connection progress and time schedule did not meet the requirements of 2nd Stage Bidding Documents).
